GDPR Privacy Notice

Trí chlárú agus freastal do pháiste ar Ghaelscoil Chnoc Liamhna admhaíonn tú go ndéanfaidh Gaelscoil Chnoc Liamhna do chuid sonraí pearsanta agus sonraí do phaiste (lena n-áirítear sonraí pearsanta chatagóir speisialta) a phróiseáil.

Tugann an Fógra Príobháideachta seo roinnt faisnéise cabhrach duit maidir le cé muid féin, cén sonraí pearsanta a bhailímid uait, cén fáth, cé leo a roinnimid iad agus cén fáth, cé chomh fada agus a choinnímid iad agus maidir le do chearta.

Soláthraímid oideachas bunscoile

Le haghaidh tuilleadh eolais ar ár bPolasaí um Chosaint Sonraí déan teaghmháil le hoifig na scoile

2. An t-eolas a mbailímid maidir leat

Agus do phaiste mar dhalta i nGaelscoil Chnoc Liamhna, bailímid agus úsáidimid a shonraí pearsanta.

I measc na sonraí pearsanta a mbailímid tá sonraí maidir le céannacht agus sonraí teaghmála; íomhána/

grianghraif (lena n-áirítear CCTV); sonraí teaghlaigh; sonraí iontrála/clárúcháin; scoileanna roimhe seo; dulchun cinn acadúil; Uimhir PSP; riachtanais speisialta oideachais; náisiúntacht; teanga; reiligiún; sonraí leighis; fainsnéis faoi iompar agus tinreamh; fainsnéis faoi shláinte, sábháilteach agus leas; fainsnéis airgeadais (maidir le táillí, deontais, scoláireachtaí srl); agus sonraí pearsanta eile.

Is féidir tuilleadh sonraí faoi na sonraí a bhailímid uait a fháil inár bPolasaí um Chosaint Sonraí.

Nuair a chláraíonn tú, bailímid ainm, seoladh, sonraí teagmhála agus fainsnéis eile faoi thuismitheoirí/chaomhnóirí. Téimid i gcomhairle le tuismitheoirí/caomhnóirí agus iarrtar orthu toiliú a thabhairt le haghaidh rudaí áirithe cosúil le grianghraif a thógáil, turais scoile srl.

3. Conas a úsáidimid fainsnéis agus an bonn dlíthiúil

Bainimid úsáid as sonraí pearsanta chun críocha lena n-áirítear:

- d'iaratas ar chlárú;
- oideachas agus tacaíocht chuí a sholáthar duit;
- monatóireacht a dhéanamh ar do dhul chun cinn acadúil;
- chun aire a thabhairt dod' shláinte agus dod' shláinte;
- cúram a thabhairt dár bhfoireann agus dár ndaltaí;
- iarratais ar dheontais, táillí agus scoláireachtaí a phróiseáil;
- cláir oideachais a chomhordú, a mheas, a mhaoiniú agus a eagrú;
- cloí lenár n-oibleagáidí dlíthiúla mar chomhlacht oideachais;
- chun ár n-oibleagáidí monatóireachta agus tuairiscithe a chomhlónadh le comhlachtaí Rialtais,
- achomhairc a phróiseáil, díospoidí a réiteach, agus dlíthíocht a chosaint srl.

Is féidir sonraí áirithe daltaí a roinnt le FSS chun críche an Chláir Sláinte Scoile. Is é an bunús dlí atá leis seo ná:

- RGCS Airteagal 6:
 - is gá an phróiseáil a dhéanamh chun oibleagáid dhlíthiúil a bhfuil an rialaitheoir faoina réir a chomhlónadh;
- RGCS Airteagal 9:
 - is gá an phróiseáil a dhéanamh chun críocha leigheas coisccheach, diagnóis leighis, cóireáil sláinte a sholáthar nó córais agus seirbhísí sláinte a bhainistiú ar bhonn dlí; agus
 - is gá an phróiseáil a dhéanamh ar chúiseanna a bhaineann le leas an phobail i réimse na sláinte poiblí, amhail cosaint i gcoinne bagairtí tromchúiseacha trasteorann ar an tszláinte ar bhonn dlí.

Tá tuilleadh faisnéise ar na sonraí a bhailímid, an fáth a bhailímid iad, an chaoi a n-úsáidfimid iad, agus an bonn dlíthiúil don bhailiú, ar fáil inár bPolasaí um Chossaint Sonrai.

4. Cé leo a roinnimid do shonraí

Roinnimid do chuid sonraí pearsanta le tríú páirtithe, lena n-áirítear comhlachtaí eile Rialtais.

Áirítear leis seo Coimisiún na Scrúduithe Stáit, an Roinn Oideachais agus Scileanna, CNOS, TUSLA, An Garda Síochána, FSS, an Roinn Coimirce Sóisialaí, na Coimisinéirí Ioncaim srl.

Is féidir sonraí áirithe daltaí a roinnt le FSS chun críche an Chláir Sláinte Scoile

Braitheann leibhéal na roinnte agus an cineál an ábhair atá ag roinnt ar fhachtóirí éagsúla. Úsáidfidh na comhlachtaí Rialtais lena n-aistrímid iad do shonraí pearsanta chun críocha a gcuspóirí féin (lena n-áirítear:

eolas eile atá á shealbhú acu cheana féin a dhearbhú srl.) agus féadfaidh siad é a chomhionlánú le heolas eile atá acu cheana féin fút féin agus faoi do theaghlaigh. Roinnimid do chuid sonraí pearsanta freisin le tríú páirtithe eile lena n-áirítear ár gcuideachta árachais agus soláthraighe seirbhíse eile (lena n-áirítear soláthraighe TF, soláthraighe slándála, comhairleoirí dlí srl.). Ní mór dúinn de réir an dlí taifid áirithe a bhaineann le dul chun cinn daltaí ina (h) oideachas a sholáthar do thuismitheoirí/chaomhnóirí an dalta, lena n-áirítear torthaí scrúduithe. Is féidir tuilleadh eolais a fháil maidir le cé leo a roinneamar do chuid sonraí, cathain agus i gcén imthosca agus cén fáth, inár bPolasaí um Chossaint Sonrai.

5. Ní aistrímid do chuid sonraí pearsanta chuig tríú thír nó chuig eagraíocht idirnáisiúnta.

6. Ní ghlacaimid páirt i gcinnteoireacht/próifiliú uathoibrithé.

7. Cá fhad a choinnímid do chuid sonraí

Ní choinnítear roinnt sonraí pearsanta ach ar feadh tréimhse ghearr (mar shampla scriosfaimid iad ag deireadh na bliana acadúla toisc nach bhfuil gá leo a thuilleadh). Tá roinnt sonraí againn a choinnímid ar feadh tréimhse níos faide (mar shampla coinnítear iad tar éis duit do pháiste a c(h)uid staidéir a chríochnú i nGaeilge Chnoc Liamhna nó má fhágann sé/sí ar chúis eile), Tá tuilleadh faisnéise ar na tréimhsí coinneála le fáil inár mBeartas um Chossaint Sonrai.

- g. Ceart agóid a dhéanamh i gcoinne cinnteoireacht/próifíliú uathoibrithe.

2. The information we collect about you

While your child is a student in Gaelscoil Chnoc Liamhna, we collect and use their personal data. Personal data we collect includes details of identity and contact details; images / photos (including CCTV);

family data; entry / registration data; previous schools; academic progress; PPS Number; special educational needs; nationality; language; religion; medical data; information on behaviour and attendance; health, safety and welfare information; financial information (regarding fees, grants, scholarships etc); and other personal data.

Further details regarding the data we collect can be found in our Data Protection Policy.

When you sign up, we collect the name, address, contact details and other information related to parents/guardians. We consult with parents/guardians and they are asked to give consent for certain things

such as taking photographs, school trips etc.

3. How we use information and legal basis

We use personal data for purposes including:

- your application for registration;
- to provide appropriate education and support;
- monitoring of academic progress;

- to take care of your child's health and welfare;
- to care for our staff and our students;
- processing applications for grants, fees and scholarships;
- co-ordinating, evaluating, financing and organising education programs;
- in order to adhere to our legal obligations as an educational body;
- to meet our monitoring and reporting obligations with Government bodies,
- processing appeals, resolving disputes, and defending litigation etc.

Certain pupil data may be shared with the HSE for the purpose of the School Health Programme. The legal basis for this is:

- GDPR Article 6:
 - processing is necessary for compliance with a legal obligation to which the controller is subject;

 - GDPR Article 9: — processing is necessary for the purposes of preventive medicine, medical diagnosis, the provision of health treatment or the management of health systems and services on the basis of law; and
 - processing is necessary for reasons of public interest in the area of public health, such as protecting against serious cross-border threats to health on the basis of law.

- Infectious Diseases (Amendment) (No. 2) Regulations 2024;
- Health (Provision of Information for Health Examination and Treatment Service) Regulations 2024.

4. With whom do we share your data?

We share your personal data with third parties, including other Government bodies.

This includes the State Examinations Commission, Department of Education and Skills, CNOS, TUSLA, An

Garda Síochána, HSE, Department of Social Protection, Revenue etc.

Certain pupil data may be shared with the HSE for the purpose of the School Health Programme

The level of sharing and the nature of content shared depends on different factors. The Government bodies to whom we transfer your personal data will be used for their own specific purposes (including verifying other information they already possess etc.) and they may also aggregate it with other information that they already have about yourself and your family. We also share your personal data with other third parties including our insurance company and other service providers (including IT providers, security providers, legal advisers, etc.).

We must in accordance with the law provide certain records relating to the progress of students in their education to the parents/guardians of the student, including examination results. Further information about who we shared your data can be found, when and in what circumstances and why, in our Data Protection Policy.

5. We do not transfer your personal data to a third country or to an international organization.

6. We do not participate in automation decision-making/profiling.

7. How long do we hold your data?

Some personal data is only kept for a short period (for example, we will delete them at the end of the academic year as they are no longer needed). We have some data that we will hold for a longer period (for example, they are retained after your child completes his/her studies in Gaelscoil Chnoc Liamhna or leaves the school for another reason). More information on the Retention periods can be found in our Data Protection Policy.

8. You have the following statutory rights that may be exercised at any time:

- a. Right to complain with a supervisory authority.
- b. Right of access.
- c. Right to correct inaccuracies.
- d. Right to be mistaken.
- e. A right to restrict processing.
- f. The right to data portability.
- g. Right to object to automated decision making/profiling.


Rinneadh an polasaí seo a dhaingniú ag cruinniú Boird Bhainistíochta.
